## Deputies Engaged in Youth Outreach Efforts

The Virginia State Society of the Sons of the American Revolution recently recognized Deputy Myrna Juarez for her actions to aid a critically injured motorist. On March 5, John Blair of the George Washington Chapter of the Sons of the American Revolution presented Deputy Juarez with an award for her efforts and response, while off duty, to a crash on I-95. Sheriff Dana Lawhorne joined Blair as he presented Deputy Juarez with the award at a Sheriff's

Deputy Juarez was driving to work in 2017 when she witnessed a car crash along I-95 near Woodbridge. She saw a car overturn and then saw a person on the road. She immediately pulled into the emergency lane, ran to the crash scene, called 911 and tried to aid the victim until medics arrived. She instructed two other passengers to try to keep traffic moving so that police and medics would not be delayed in reaching the crash scene. Even after Virginia State Police arrived, Deputy Juarez remained on the scene and continued efforts to help the critically injured man until EMS took over. Although the victim did not survive, Deputy Juarez's efforts are to be commended.

Again this year, deputies have been engaged in lots of outreach activities and hope to have a positive influence on young people.

Lieutenant Sean Casey, Sergeant Valarie Wright, Deputy Deon Eaddy and Deputy Samira Denardo all visited MacArthur as guest readers for Mr. Holland's third grade class. The deputies read books to the students and students can ask the deputies questions.

Lieutenant Casey, Sergeant Wright and Deputy Morgan Garner all volunteer as mentors to students at Charles Barrett. On a regular basis, they stop by for a visit at lunchtime and take part in after school activities. Sometimes they just check in to see how their students are doing and offer encouragement.

The Sheriff's Office has also welcomed teens on tours, including a scout visiting the Detention Center and hosting students in Casa Chirilagua's mentoring program at the courthouse so they could learn more of about Alexandria's criminal justice system.

Most recently, Sergeant Wright joined the Substance Abuse Prevention Coalition of Alexandria and students from T.C. Williams for "Kick Butts Day" to raise awareness about the dangers of tobacco, smoking and e-cigarettes on young people. Then later this spring, the Sheriff's Office and the Police Department will host graduating seniors from T.C. for Senior Experience.

## Mill Road Update

Has anyone been back to 2003 Mill Road in a while? General Services, the Hack Office, and Alexandria Criminal Justice Services (commonly known as “pre-trial”) are now on the first floor and there is also an exercise room for Sheriff’s Office staff pretty much where the patrol office was. The Sheriff’s command and administrative staff are on the second floor where APD Personnel, CSI (or ID) and CIS used to be, but the old communications room is still there and can be used as the backup 911 center. The Office of Emergency Management now has its offices on the third floor with the new Emergency Operations Center located where the former APD administrative staff cubicles originally were and where the Sheriff’s administrative staff was before they moved to the second floor.

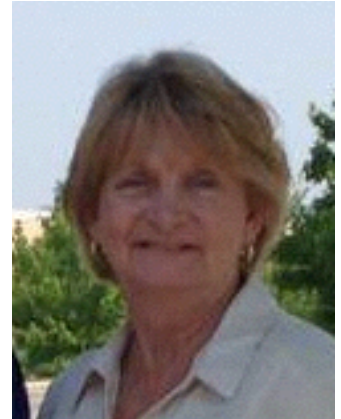
